If you wish to regain eligibility sooner, you may submit this form to alert the Office of Financial aid that you now meet the minimum SAP requirements and that wish to have your eligibility reinstated. To determine if you currently meet the minimum SAP requirements you and your advisor may complete the worksheet on the reverse side.

Deadlines for Submittal: Request for Reinstatement of Suspended Aid forms must be complete and received by noon on the following dates in order to have your eligibility reviewed for the start of the term: Summer: July 13, 2018; Fall: September 7, 2018; Winter: December 21, 2018; Spring: March 22, 2019. You may submit this request prior the posting of your current term grade if you are confident that grade will allow you to meet the SAP minimum standard. If your grades are not posted by the end of the first week of the term you will need to make an alternate payment arrangement in order to remain in classes.

Do You Meet the Minimum SAP Standard?

There are 3 factors that go into determining whether or not you are meeting SAP standards. Your advisor and/or WebROCK can help you answer these questions.

1. What is Your Current GPA? _____

You can view your cumulative GPA by going to WebROCK/Student Records/View Academic History/Transcript Totals. It will be listed under 'Overall GPA' at the bottom right of the screen.

- Students enrolled in undergraduate programs must have a minimum 2.0 cumulative GPA.
- Students enrolled in post-baccalaureate and graduate programs must have minimum a 3.0 cumulative GPA.

2. What is Your Current Completion Rate?

You can calculate your completion rate by going to WebROCK/Student Records/View your Academic History/Transcript Totals. You will divide the 'Overall Earned Hours' by the sum of the 'Total Transfer Earned Hours' and 'Overall Attempted Hours'.

$$\frac{\text{Overall Earned Hours}}{(\text{Total Transfer Earned Hours} + \text{Overall Attempted Hours})} = \text{Completion Rate (round up .666 to 67)} \%$$

Your completion rate must be at least 67% for all programs of study.
